Cover

 Public and Products Liability cover available with indemnity limits of either £1m, £2m or £5m.

Optional covers

- Employers' Liability up to £10m.
- Tools up to £10,000 per employee for tools and portable electronic equipment, with a single item limit of £1,500.
- Contract Works up to a contract price of £1m with cover for own and hired in plant, tools and temporary buildings.
- Personal Accident up to £10,000 per unit up to five units.
- Commercial Legal Expenses financial support up to £250,000 for any one event and up to £1m for any one period of insurance for selected events including:
 - employment disputes
 - contact disputes
 - criminal prosecution defence
 - taxation proceedings
 - statutory licence appeals.

- Property Damage cover for contents, computers, buildings and stock.
- Business Interruption cover for either loss of gross profit, revenue or increased cost of working only, following loss or damage covered by the Property Damage section.
- Property Damage/Business Interruption - combined sum insured of up to £1m.
