Sector-specific cover for businesses with a combined property and casualty premium between £5,000 and £100,000, traded via our branch network.

Cover

We know that your professional services customers have unique needs. In addition to the standard cover provided by our Commercial Select product, Professional Services offers additional tailored cover for their sector-specific risks.

The following cover extensions are automatically included free of charge if the relevant section is operative.

Professional Indemnity

- Lost Documents £250,000.
- Court Attendance Costs £500 per person, per day for any partner or director, and up to £250 per person per day for any employee.

Material Damage

- Exhibitions Cover 50,000 limit (UK), £25,000 (EU).
- Full Theft During Business Hours.
- Plans, Models and Drawings -£250,000 (UK) £100,000 (EU).
- Fine Art, Antiques and Collectibles - £250,000, any one claim.

 Partner's, Director's, and Employee's Belongings - cover whilst away from the insured premises, £2,500 per person.

Business Interruption

- Flexible Loss Limits cover is available on a flexible loss limit basis. Covering a combination of loss of revenue or income, increased costs of working, and additional increased costs of working, up to a loss limit selected by your customer.
- Unnamed Customers/Suppliers - £250,000 (UK) and £100,000 (EU).
- Research and Development Costs - £250,000.
- Additional Increase in Cost of Working - £50,000.

Personal Accident

Complimentary personal accident cover, up to £10,000 for an accidental injury sustained at work, resulting in either death or disablement.

Business Travel

Complimentary medical expenses and associated covers - up to 30 trips, up to a limit of £25m. Additional cover can be purchased.
