- Eviction of squatters – £5,000 limit, any one claim
- Archaeological discovery – £50,000 limit, any one claim
- Concern for welfare and emergency services covers – £10,000 limit, any one claim
- Property damage caused by illegal cultivation of drugs
- Residential property alternative accommodation – up to 30% of the building declared value
- Japanese knotweed removal – £2,500 in the aggregate
- Environmental protection – 10% of building sum insured or £25,000 for the use of green and sustainable rebuild material
- Fly-tipping – £10,000 limit, £25,000 in the aggregate
- Exhibitions and models – £25,000 limit in the aggregate
- Average free – we will waive the Average condition if a professional valuation has been undertaken within the last three years. Proof of valuation will be required at point of claim.

Loss of Rent

We offer loss of income or rent protection following an insured event, including FREE indemnity to managing agent and book debts.

Property Owners Liability

Legal liabilities cover for personal injury or property damage suffered by third parties

arising from ownership of the property.

- Legionella – £5,000,000 limit of indemnity
- Corporate Manslaughter – £5,000,000 limit of indemnity
- Asbestos – £5,000,000 limit of indemnity
- Terrorism – £5,000,000 limit of indemnity
- FREE environmental clean-up costs – £1,000,000 limit.

ADDITIONAL COVERS

Available at cost:

Machinery Damage – for machinery such as boilers, lift and escalators that service a property, covers damage caused by breakdown, explosion and collapse for machinery. £1,000,000 limit, and own surrounding property £2,000,000 limit.

Computer – All Risks cover, including theft and breakdown for computers and auxiliary equipment and includes e-risks cover as standard. Covers reinstatement of data from other records and additional expenditure, losses following a virus or hacking, as well as seek and destroy cover.

Directors & Officers – cover for company directors, officers and managers to protect them from claims that may arise from the decisions and actions taken within the scope of their regular duties. Bespoke residential association D&O wording is also available.

Excess of Loss – layers of cover across multiple classes of business up to £50,000,000, available on a short-term or annual basis for most trades and professions.
