
Major loss claims example In this tragic motor claim, our policyholder (the driver) hit a pedestrian, causing spinal injuries that resulted in paralysis and serious fractures to both legs. The injured person found himself in an unimaginable life-changing situation, unlikely to be able to return to work and provide for his family due to the injuries he sustained. To add to this, he was living in a rented house that was unsuitable for his physical needs.

The sensitive but critical issue of replacement accommodation for the injured man and his family needed to be addressed immediately. We swiftly agreed the early release of enough money for him to purchase a replacement house. We then arranged for it to be adapted as quickly as possible, allowing the family to live under the same roof once again.






